

RAISIN'S RANCH Equine Activity Release and Hold Harmless Agreement

Release of liability forms must also be signed by every child's parent or guardian before children are allowed on or around the horses or other animals at Raisin's Ranch, LLC.

WARNING! Under Georgia law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities, pursuant to Chapter 12 of Title 4 of the Official Code of Georgia Annotated.

1. I, _____, have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Raisin's Ranch, LLC. Understanding that this Release and Hold Harmless Agreement is a waiver of any and all liability(ies) concerning me or my child(ren).

2. I understand the potential dangers that I or my child(ren) could incur in mounting, riding, walking, feeding, interacting with this horse or interacting with any animals owned by Raisin's Ranch, LLC. Understanding those risks, I hereby release Raisin's Ranch, LLC, it's owners, representatives, employees and anyone else directly or indirectly connected with Raisin's Ranch from any liability whatsoever in the event of injury or damage of any nature (or perhaps even death) to me, my child or anyone else caused by or incidental to electing to mount, ride, or interact with a horse or animal owned, boarded, operated, or on the property owned by Susan Purcell Vojnovic or Greg Vojnovic / Raisin's Ranch, LLC.

3. I understand and recognize and warrant that this Release and Hold Harmless Agreement, is being voluntarily and intentionally signed and agreed to, and that in signing this Release and Hold Harmless Agreement I know and understand that this Release and Hold Harmless Agreement may further limit the liability of equine professionals to include any activity, whatsoever, involving an equine or animal, including death, personal injury and/or damage to property.

4. I further voluntarily agree and warrant to Release and Hold Harmless this (these) equine professional(s) from any liability whatsoever, including, but not limited to, any incident caused by or related to said equine professional's (s') negligence, relating to injuries known, unknown, or otherwise not herein disclosed; including, but not limited to, injuries, death or property damage from: mounting, riding, dismounting, walking, grooming, feeding, in any capacity; falling off horse whether horse is bucking, flipping, spooked; or my or my child's failure to understand any equine professional's directions relating to my riding or otherwise use and control, or lack thereof, of my horse or the horse I or my child have been assigned to. This includes my or my child's interaction with any and all animals located at and owned by Raisin's Ranch, LLC.

5. As unforeseen events may occur, Raisin's Ranch, LLC cannot be held responsible for those considered to be an act of God, theft, accidents, or incidents that occur while participating in any event at Raisin's Ranch located at 17955 Birmingham Hwy, Milton, GA 30004.

I have read the above statement and agree to hold Raisin's Ranch and it's owners and representatives harmless in the event of injury, death, or damage to property.

RAISIN'S RANCH SAFETY RULES

Please familiarize yourselves with the Safety Rules. Think safety and act accordingly at all times. Ensure children are attended at all times.

Parents must supervise children at all times.

- Do not go behind or stand behind the ponies. All animals are unpredictable.
- Do not open gates or enter pastures or stalls unless accompanied by a Raisin's Ranch rep.
- No noise makers (balloons, poppers, fireworks, personal fans, etc...) around the animals.
- Do not approach or ride the pony unless accompanied by a Raisin's Ranch representative.
- No spooking the animals. No hitting animals. No throwing things at the animals.
- Do not feed the pony/animals unless accompanied by a Raisin's Ranch representative.
- All children should wash their hands after playing with the pony/animals.

Raisin's Ranch reserves the right to deny any child/person contact with the pony/animals if that child/person is not complying with safety rules or instructions or whose actions may be harmful to the pony/animals. Raisin's Ranch, LLC or its representatives/owners are not responsible for accidents, injury, or property damage. (see Hold Harmless Agreement)
